**Explanation of Responses:**

- The restricted stock units (RSUs) vest and settle into common stock over a four-year period with 25% of the RSUs vesting and settling into common stock on the one year anniversary of the grant date and the remaining 75% of the RSUs vesting and settling into common stock in equal quarterly installments over the next three years, becoming fully vested on March 18, 2024.
- The option vests in equal monthly installments over a four-year period, becoming fully vested on March 18, 2024.
