- The option vests over a four-year period with 25% of the shares of common stock underlying the option having vested on March 7, 2019 and the remaining 75% of the shares of common stock underlying the option vesting in equal monthly installments thereafter, becoming fully vested on March 7, 2022.
- The option vests over a four-year period with 25% of the shares of common stock underlying the option vesting on February 5, 2020 and the remaining 75% of the shares of common stock underlying the option vesting in equal monthly installments thereafter, becoming fully vested on February 5, 2023.
